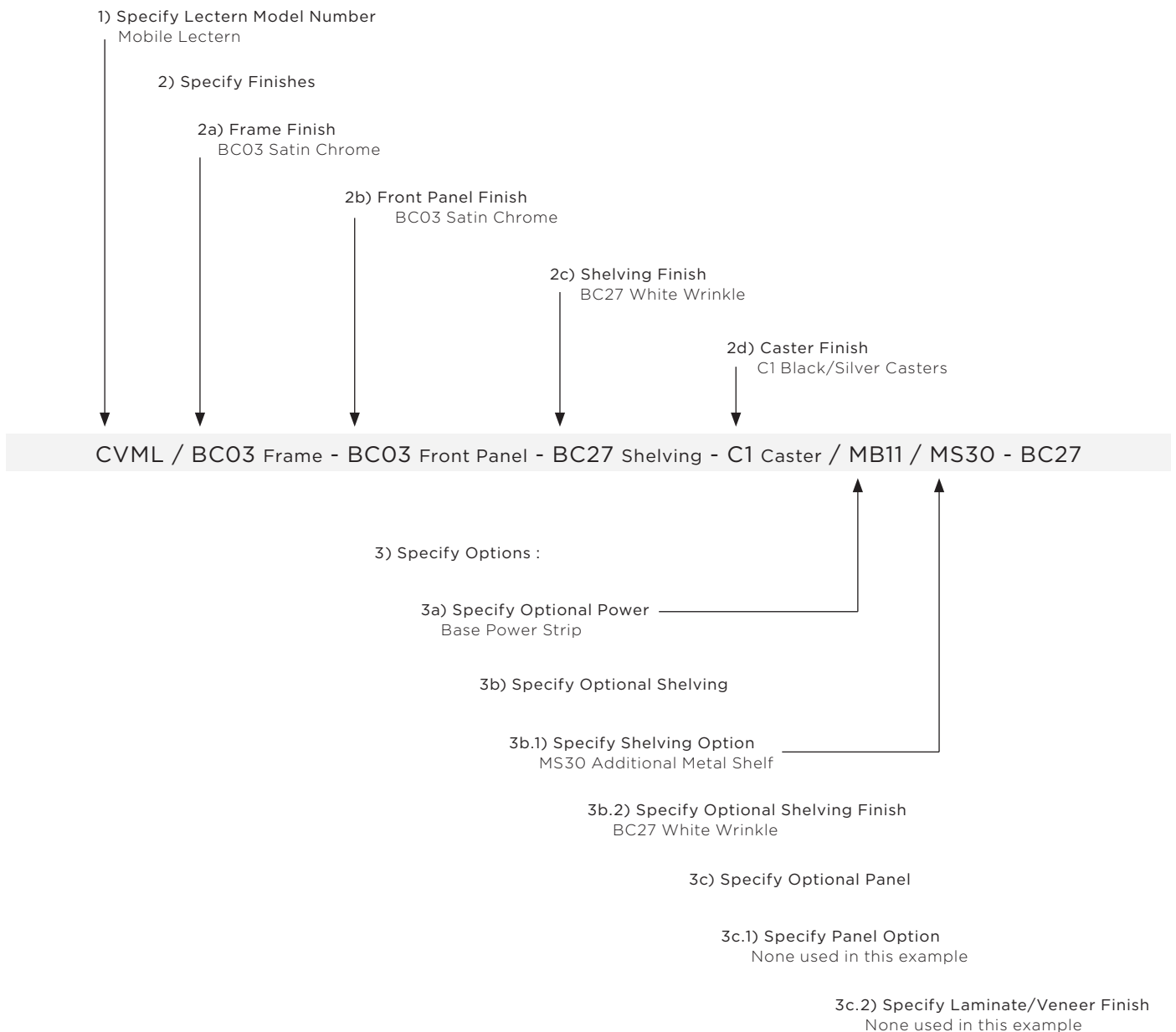
How To Specify
